IPM statement

It is the goal of LEAP Children's Center to implement IPM by focusing on long-term prevention or suppression of pests through accurate pest identification, by frequent monitoring for pest presence, by applying appropriate action levels, and by making the habitat less conducive to pests using sanitation and mechanical and physical controls. Pesticides that are effective will be used in a manner that minimizes risks to people, property, and the environment, and only after other options have been shown ineffective.

Our pest management objectives are to: *(Example: Focus on long-term pest prevention)*

Focus on long term prevention by eliminating access to shelter, water and food. Provide pest prevention education for all staff. Limit use of pesticides to "as needed".

- Eliminate pest access to water, food and shelter by: taking trash out after every meal, moving around permanent furniture monthly, sealing cracks and repairing leaks.
- Maintaining a nightly Cleaning Contract and a monthly Pest control contract with reputable companies.
- Use of sticky traps, door sweeps and snap or containment traps

¹ These pesticides are exempt from all Healthy Schools Act requirements, except the training requirement: 1) products used in self-contained baits or traps, 2) gels or pastes used as crack and crevice treatments, 3) antimicrobials, and 4) pesticides exempt from U.S. EPA registration. (Education Code Section 17610.5)
