During the 2023-2024 fiscal year, all classrooms were full. We served 118 students. Families become resilient through relationships with community organizations and with one another. FRC services continued in FY 2023-2024. This year, LEAP's diaper bank provided more than 55,000 diapers to more than 2,000 children. In partnership with Immigrant Hope, the FRC hosted bi-monthly immigration webinars, providing accurate information about the changing laws relating to immigrants. The FRC expanded their offerings to include webinars on financial literacy and tenants' rights.

Total program expenses were \$265,111. Total program revenues were \$0.
