including children with special needs.

IVYP's Family Resource Center uses the five protective factors to strengthen families,
prevent child abuse, and grow a healthy community. Specific programs and resources
include, but are not limited to: resource and referral, family and individual
counseling, parenting classes, budgeting classes, translation support, emergency food
pantry and other concrete support. The Family Resource Center serves more than 2,000
individuals each year. Childcare is provided for all classes.

IVYP's School Aged Enrichment Program provides after school and summer care and
activities at Isla Vista Elementary School. During the school year, 150 children

nutrition program.
