California Department of Education: When children are cared for in a safe, stimulating and high quality environment, they grow up to be lifelong learners and families are able to work or go to school in order to provide for their families. Our two Isla Vista Children's Center sites are blended programs serving both state-certified and private pay students. Our curriculum is designed to facilitate cognitive, emotional, physical, social and creative growth to children between the ages of 3 months and 6 years in a language-rich environment that supports the ethnic and cultural diversity of the children. In Fiscal Year 2018-19, we educated 37 infants/toddlers and 98 preschoolers.

Family Resource Center: Families become resilient through relationships with community organizations and with one another. IVYP's Family Resource Center provides parent education classes, case management, monthly food distributions, an emergency personal care and food pantry on site, clothing distributions, home visitation, and enrollment services for CalFresh, Medi-Cal, WIC and other resources community engagement events. In Fiscal Year 2018-19, IVYP's Family Resource Center expanded its offices to a new located in Old Town Goleta in order to lessen barriers to entry for our families. This past year we hosted four immigration forums, two emergency preparedness fairs, 3 parenting workshops, and 12 healthy food pantry food distributions. In Fiscal Year 2018-19: 3,226 families received services.

School Aged Programming: Children build resilience when they have access to enriched social, educational and recreational opportunities. IVYP's After-School and Summer Enrichment Program provides K-6 children with homework assistance, enrichment activities, and a safe environment to learn and grow. In Fiscal Year 2018-19, IVYP expanded our Afterschool program to an include El Camino Elementary school in addition to Isla Vista Elementary. In Fiscal Year 2018-19, 226 children participated in our school aged programming.
